1. **DEFINITIONS:**

- "Agreement" means the terms and conditions of this SaaS Agreement.
- "Claim" shall mean any liability, suits, claims, actions, proceedings, losses, damages, judgments and reasonable costs.
- "Documentation" shall mean the instructions and/or user manuals either digital or otherwise that describe installation, use, and/or operation of the Service.
- 1.4 "ERP" shall mean Enterprise Resource Planning.
- 1.5 "i-View System" shall mean a Cloud Based Program provided by the party of the First Part.
- "Intellectual Property Rights" shall mean copyright, patents, designs, trademarks, trade names, goodwill rights and trade secrets.
- 1.7 "Proposal" means the services and system to be devised and provided by PTPL as set out in PTPL letter dated 29th June 2019.
- 1.8 "SaaS" refers to Software as a Service.

"License Term" shall be the limited period as specified in the Agreement, unless otherwise provided.

- 5.3 All other taxes shall be borne by the Party responsible to bear and pay such tax as per law.

CONFIDENTIALITY:

- 6.1 The Party of the First Part shall keep all information including but not limited to Service, Documentation or any other documentation, methods, processes, data of the Users shared with respect to the Agreement as proprietary of the Party of the Second Part and treat the same as confidential and shall not disclose or sell such information to any third party, except, disclose pertinent aspects of the Agreement to government and / or regulatory authorities, as required by law.
- The party of the First part shall ensure that any person having access to 6.2 or use of the Service provided to Second Party under this Agreement is subject to an obligation of confidentiality with respect thereto at least as restrictive as the confidentiality obligations.
- The Party of the First Part shall strictly secure the data received from the Second Party, more particularly of students considering that a large section of the students are minors and their confidential data cannot be shared, leaked or in any manner misused. The party of the First Part will be solely responsible for any breach of this term

8. TERMINATION:

- 10.2 The Party of the First Part and Second Part are independent and district legal entities and the contract to provide service is on principal to principal basis.

11 ARBITRATION:

- 11.8 The Award of the arbitration proceedings shall be final and binding on the Parties.

12 GOVERNING LAW AND JURISDICTION:

12.1 This Agreement shall be governed by and construed under the laws of India. Subject to arbitration clause above, any dispute arising out of or in relation to this Agreement shall be submitted to the sole jurisdiction of the courts of law at Mumbai.

13 FORCE MAJEURE:

13.1 However, the Party of the First Part shall not be held liable for any damage or loss due to deficiency in performance of the Service resulting directly or indirectly from acts of nature, forces, or causes beyond its reasonable control, including internet failures, computer equipment failures, telecommunication equipment failures, power failures, internet outage, or any other government regulations, floods, storms, electrical failure, civil disturbances and riots.

14 MISCELLANEOUS:

Notices

No delay or failure of either Party in exercising any right and no partial or single exercise of any right shall be deemed to constitute a waiver of that right or any other rights under this Agreement.


